## EXECUTIVE SUMMARY

This report presents the IRIS services performance during January 2024. The report contains global results for the reported period, including maps and tables with the performance through different parameters.

Additional and more detailed information about IRIS performance can be found at the [Iris User Support Website](#).

### **Iris ATN/OSI Service Level 1 (SL1)**

This Service Level enables the following RCP specifications supporting CPDLC application for ATN B1 and ATS B2 data link services:

- RCP specified in the ED-120 as interpreted in the Eurocontrol guidelines.
- RCP130/A1 specified in the ED-228A / DO-350A and referred in the ED-242C / DO-343D

The SL1 performance values fulfilled the target values defined in the Iris SDD in the 89.7% of the ACCs in which the Iris SL1 is provided.

The values for the whole Iris Service Area are:

- SL1 Nominal Transaction Time ( $\leq$ 10 seconds at 95%): 4.8s
- SL1 ATS B2 Expiration Time ( $\leq$ 24 seconds at 99.5%): 7.8s
- SL1 ATN B1 Expiration Time ( $\leq$ 18 seconds at 99%): 5.2s
- SL1 ATN B1 Technical Continuity ( $\geq$ 99%) was 98.7%
- SL1 ATS B2 Technical Continuity ( $\geq$ 99.5%) was 98.3%

From previous results, it can be observed that Iris performance during the reported period have been compliant for the latency parameters, but the continuity parameters were slightly below the target. This underperformance is generated due to some CPDLC provider aborts and messages not received. The low number of samples generates big disturbances when some issues appear.

### **Iris ATN/OSI Service Level 2 (SL2)**

This Service Level 2 which enables the following RSP specification supporting ADS-C application for ATS B2 data link services:

- RSP160/A1 specified in the ED-228A / DO-350A and referred in the ED-242C / DO-343D

The SL2 performance values fulfilled the target values defined in the Iris SDD in the 100% of the ACCs in which the Iris SL2 is provided.

The values for the whole Iris Service Area are:

- SL2 Nominal Delivery Time ( $\leq$ 9 seconds at 95%): 5.8s
- SL2 Overdue Delivery Time ( $\leq$ 17 seconds at 99.5%): 7.8s
- SL2 Technical Continuity ( $\geq$ 99.5%): 100.00%

From previous results, it can be observed that Iris performance during the reported period fulfilled the commitments.

Further details can be found in section 3.

During the reported period, the total number of Iris aircrafts connected and handled has been 1.



## 1 IRIS SERVICE AVAILABILITY

*The service availability is defined as the probability that the Iris service is available to provide the required level of communication service.*

*Operationally significant outages are considered where TP4 or CM, CPDLC / ADS-C messages are not exchanged anymore for more than 6 minutes and validated by taking into consideration the type of IDRPs messages (e.g. IDRPs error rate) sent or received by the Inmarsat Air/Ground Router during this period of time in order to avoid wrong measurements at low traffic periods.*

Due to the low number of available samples, the Iris Service Availability cannot be reported for this month.

## 2 IRIS ATN/OSI SERVICE LEVEL 1 (SL1)

Iris ATN/OSI Service Level 1 corresponds to the Controller Pilot Data Link Communications (CPDLC), which is the application that allows ATC data communications between controllers and pilots.

### 2.1 Latency

*SL1 Nominal Transaction Delay (TD) is defined as the maximum time at which 95 percent of all transactions, that are initiated, are completed.*

*It is computed as the time from when the uplink message is sent by the end-user ground system (as time-stamped by the ground system in the uplink message) and the time when the downlink LACK is received by the end-user ground system for the 95 percent.*

*SL1 ATS B2 Expiration Time (ET) is defined as the maximum time at which 99.5 percent of all transactions, that are initiated, are completed, after which the initiator is required to revert to an alternative procedure.*

*It is computed as the time from when the uplink message is sent by the end-user ground system (as time-stamped by the ground system in the uplink message) and the time when the downlink LACK is received by the end-user ground system for the 99.5 percent.*

The achieved performance values for the reported period are:

Parameter	Value
TD	4.8 seconds
ET (RCP as ED-120)	5.2 seconds
ET (RCP130/A1)	7.8 seconds

### 2.2 Technical Continuity

*SL1 ATN B1 Technical Continuity is defined as probability that a transaction completes before the Expiration Time (ET) expires.*

*It is computed as the number of uplink messages requiring a LACK (ACK = 1) for which a DM100 LACK or a DM62 ERROR response is received within the ET target value (as per the Iris SDD) or less / total number of uplinks requiring a LACK (ACK = 1).*

The achieved performance values for the reported period are:

Parameter	Value
C [TD]	98.6 %
C [ET (RCP as ED-120)]	98.7 %
C [ET (RCP130/A1)]	98.3 %




Figure 1: Cumulative performance distribution for ISP (SL1), for January 2024




Figure 3: SL1 ET – January 2024 (RCP as ED-120)




Figure 4: SL1 ET – January 2024 (RCP130/A1)

### 3 IRIS ATN/OSI SERVICE LEVEL 2 (SL2)

Iris ATN/OSI Service Level 2 corresponds to the Automatic Dependent Surveillance – Contract (ADS-C). A mean by which the terms of an ADS-C agreement will be exchanged between the ground system and the aircraft, via a data link, specifying under what conditions ADS-C reports would be initiated, and what data would be contained in the reports.

#### 3.1 Delivery time

*SL2 Surveillance nominal delivery time (DT) is defined as the maximum nominal time within which 95% of surveillance data deliveries are required to be successfully delivered.*

*It is computed as the time from when the downlink message is sent by the aircraft (as time-stamped by the aircraft system in the Basic Group downlink message) and the time when the downlink message is received by the Organization ground system for the 95 percent.*

*SL2 overdue delivery time of surveillance data (OT) is defined as maximum time for the overdue delivery time of surveillance data at which 99.5 percent of all transactions, that are initiated, are completed, after which the initiator is required to revert to an alternative procedure.*

*It is computed as the time from when the downlink message is sent by the aircraft (as time-stamped by the aircraft system in the Basic Group downlink message) and the time when the downlink message is received by the Organization ground system for the 99.5 percent.*

The achieved performance values for the reported period are:

Parameter	Value
DT	5.8 seconds
OT	7.8 seconds

#### 3.2 Technical Continuity

*SL2 Technical Continuity is defined as probability that a transition completes before the Surveillance overdue delivery time (OT) expires.*

*It is computed as the number of ADS-C downlink messages which are forwarded to the Organization within the target value (as per the Iris SDD) or less / total number of ADS-C downlink messages.*

The SL2 technical continuity during the reported period is 100%.

The following figure presents the delivery time of the messages for the Service level 2, for the percentile between 90% and 100%.




Figure 5: Cumulative performance distribution for ISP (SL2), for January 2024




Figure 6: SL2 DT - January 2024




Figure 7: SL2 OT - January 2024
